10. Mr. Kenney recapped state aid information, noting the Governor's proposal provides an increase in aid of more than 3% to the average NYS school district. However, due to PCSD's above average wealth and low need, the Governor's proposal results in a reduction of 2%; \$365,000 for Pittsford. Mr. Starowicz suggested that the community be made aware of facts like this. Mrs. Wayman noted that we do include this kind of information in our communications to the community.
