Dear Parents,

This letter contains information about required health documentation for your child. New York State Education Law requires each new student to provide proof of required immunizations within 14 days of their entrance into school or 30 days if from out-of-state and proof of a physical examination **within 30 days of their entrance into school**. The law also requires school districts to request dental health certificates.

Enclosed in this packet is a health appraisal form, a student health information form and a dental health certificate.

Health Appraisal Form

- This is to be completed by your child's physician.
- Please ask your physician's office to record all immunizations when they are given. The required immunizations are diphtheria, pertussis, polio, measles, mumps and rubella (MMR), tetanus, Hepatitis B, and Varicella (doctor documentation of Varicella may meet this requirement.)
- Acceptable physicals are those dated no earlier than September 2, 2014.

Student Health Information Form

- This is to be completed by you, the parent.
- This form provides us with more specific information than the health appraisal form to assist us in providing a healthy and safe environment for your child. During the school year, please advise the school nurse teacher/school nurse of any changes in your child's health status.

Dental Health Certificate

- This form is to be completed by your dentist.
- A list of dentists is available upon request from your school nurse for those families who qualify for an examination on a free or reduced cost basis.

Please return the completed forms to your child's health office within thirty days of the date your child(ren) started school. For further information, please feel free to call the nurse at your child's school. Thank you for your assistance.
