



## What's new this year: changes in the property tax laws Tax Cap

Legislation signed into law in June 2011 requires districts to calculate their own tax levy limits annually. Originally referred to by some as the 2% tax cap, the law actually requires use of a somewhat complicated eight-step formula based on several factors. Tax levy cap calculations in area school districts have resulted in allowable increases ranging from under 2% to over 4%.

Using the State's Tax Cap formula, PCSD has a tax cap of 3.6%. However, the Board is seeking a tax levy increase of 3.2% which is BELOW the tax cap.

## **Contingent Budget**

If voters in the district reject the proposed budget, the board of education may put up the same or a revised budget for a second vote, or adopt a contingency budget with a tax levy no greater than what was levied the previous year. If voters reject the spending plan twice, schools must adopt a budget with the same tax levy as the prior year essentially a zero percent cap.




